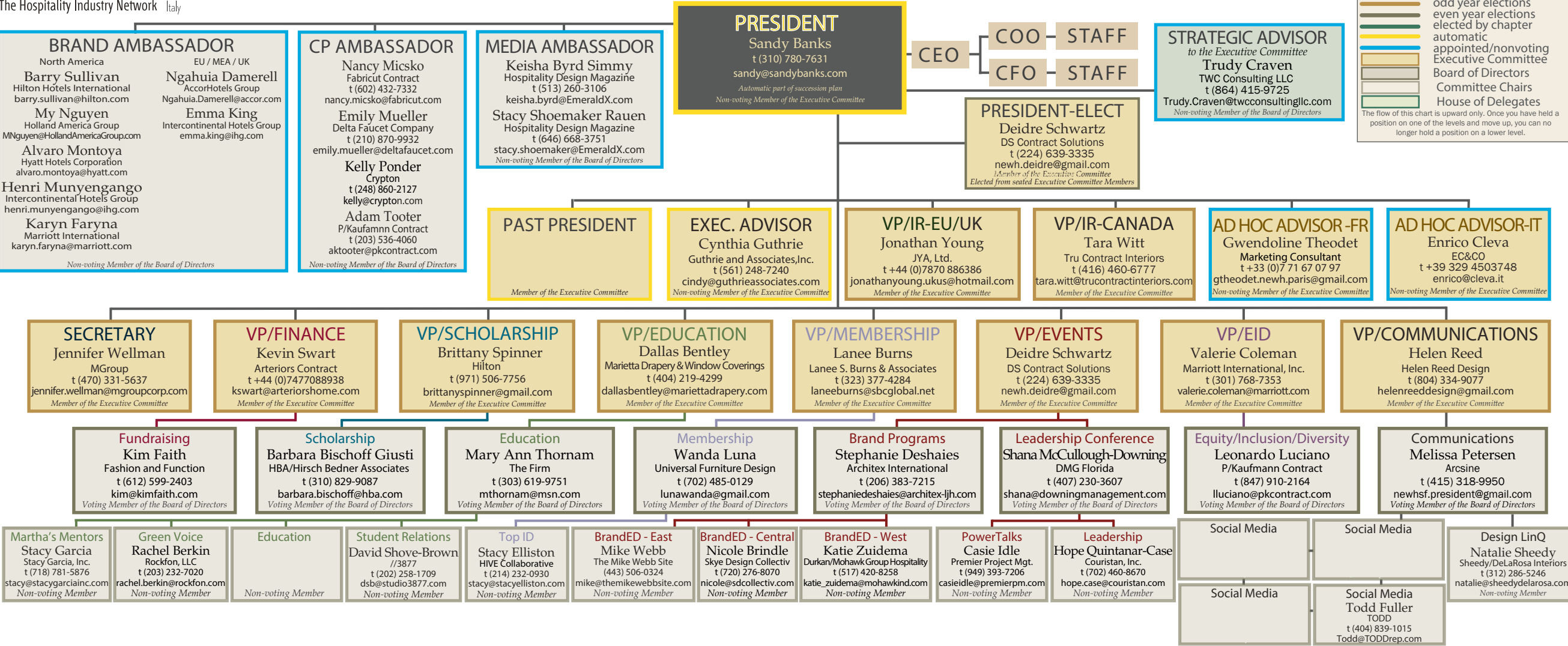


2025 Board of Directors Organizational Chart
